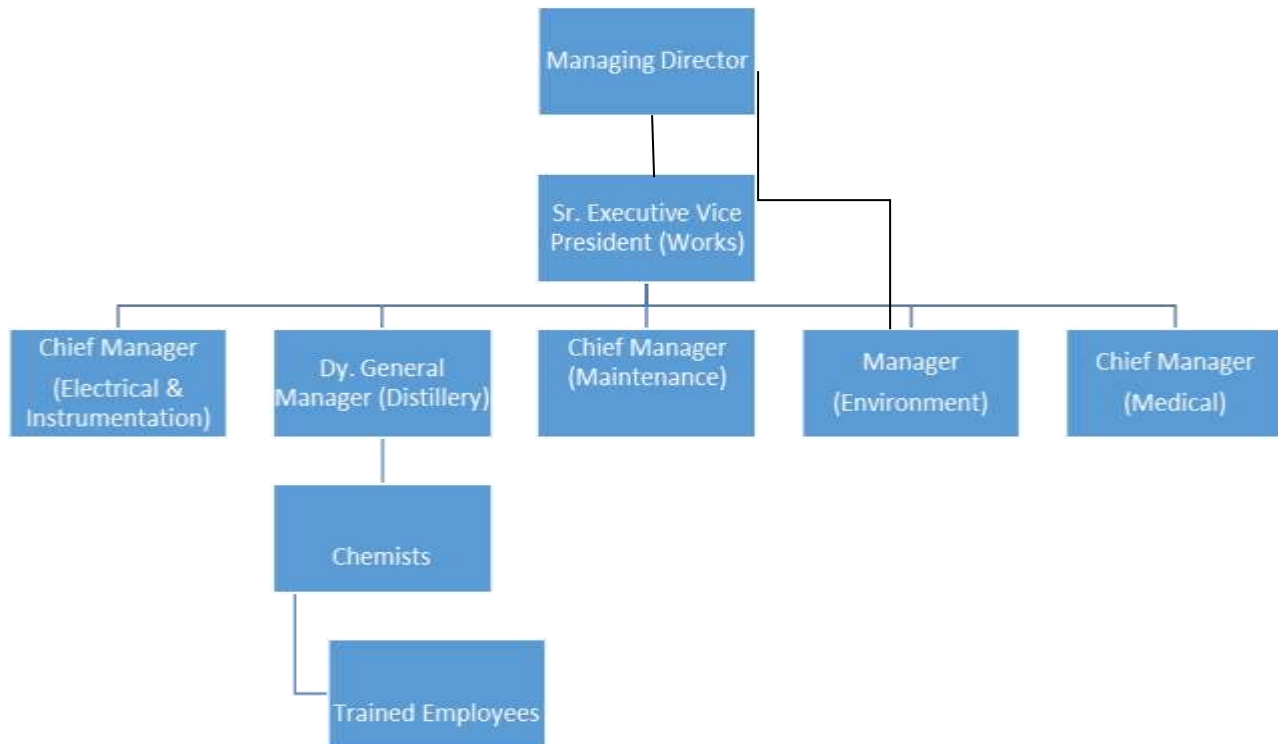
## **CORPORATE ENVIRONMENT POLICY**
